The Majeng community had been forcibly removed from the Majeng farms and subsequently (after decades) awarded the rights to the farms following a ten-year land claims case. OneWorld was commissioned to develop an integrated development and business plan for the community of Majeng and to build the associated capacity within the community and its structures. Conducted needs assessment and capacity development process for the Majeng Community; conducted a socio-economic survey of the land claimants, which involved an extensive stakeholder engagement process and participatory analysis; managed and facilitated relationships of public and private sector actors throughout the business plan development process; delivered a product that was fully owned by the beneficiary community. In total, there were 45 engagements with stakeholders – nine project steering committee meetings, eight site visits and five community meetings.
